Cleaning Instructions

Proper care and cleaning is important to the life of all fabrics. Brush loose dirt and, twigs and leaves from the fabric.

For normal cleaning use a mild soap and luke warm water mix. Clean the fabric with a soft brush and rinse thoroughly with cold water and allow to air dry.

For stubborn stains a mixture of a maximum of 236 ml of bleach to 3.78 ltr of water. Spray it lightly onto the fabric "face" (non-coated side). Do not soak the fabric. Rinse immediately. Leaving harsh chemicals on the fabric can damaged the coating on the underside of the fabric.

After cleaning with harsh cleaners (such as bleach) the fabric should be treated to restore the water repellency. We recommend 303 High Tech Fabric Guard
